MINUTES OF THE VILLAGE OF LIBERTYVILLE BOARD OF FIRE AND POLICE COMMISSIONERS May 30, 2018

ENTRY-LEVEL POLICE EXAMINATION LOGISTICS

The Commission reviewed the Rules of the Board of Fire and Police Commissioners with regard to Entry-Level POLICE testing. After discussion, Commissioner LASKA moved to set the passing score for the written portion of the score at 70 or above. Seconded by Commissioner WEIL, the motion passed on a unanimous voice vote.

The Commissioners correlated schedules and directed Chief HERDEGEN to notify candidates who passed and give notice to request preference points. The Commission directed to schedule 30-minute oral examinations for the top 30 (plus any ties) candidates rated by score and the addition of any preference points to be scheduled on 7/10, 7/12 and 7/17, between 5:30pm and 7:30pm, and on 7/14 between 8am and 2pm. The Commission reviewed interview questions, scoring and interview logistics. The Commission directed that oral examinations be held at the Libertyville POLICE department.

ENTRY-LEVEL FIRE EXAMINATION LOGISTICS

The Commission reviewed the Rules of the Board of Fire and Police Commissioners with regard to Entry-Level FIRE testing.

The Commissioners correlated schedules and directed Commissioner LASKA to inform Chief CARANI to notify candidates who passed and give notice to request preference points. The Commission directed to schedule 30-minute oral examinations for the top 30 (plus any ties) candidates rated by score and the addition of any preference points to be scheduled on 9/15 between 8am and 2pm and on 9/20, 9/25 and 9/27, between 5:30pm and 7:30pm. The Commission reviewed interview questions, scoring and interview logistics. The Commission directed that oral examinations be held at the Libertyville FIRE department.
