**Action Items**

Incorporate ANHMP in Other Plans

The Village incorporated goals and action items from the ANHMP as follows:

- Recommendations from our Master Stormwater Management Plan (adopted May 28, 2019) were included in the design for upcoming projects (for improved capacity of drainage systems, property protection/flood mitigation, and increased stormwater detention capacity)
- Annual Sanitary Sewer Inflow & Infiltration (I/I) Rehabilitation, including spot repairs, cleaning & televising, and sewer lining (reduced I/I to protect against sewer backups)
- Schertz Building Generator Replacement and Route 45 Lift Station Standby Generator (alternate power sources for critical facilities)
- Miscellaneous Storm Sewer Improvements (maintain drainage systems)
- Continued participation as a StormReady, CRS Class 6, and Tree City USA Community

Continued Implementation of Requirements

The Village has maintained good standing with the National Flood Insurance Program (NFIP) and continues all our responsibilities as a Certified Community under the Lake County Watershed Development Ordinance (WDO).

### Property Protection Projects

---

The Village of Libertyville incorporated recommendations from our Master Stormwater Management Plan into the design for upcoming construction projects, including our Rockland Road Corridor Flood Reduction Project and drainage improvements in the Highlands Subdivision study area.

### **Objectives**

During the year 2020, the Village of Libertyville made progress on our objectives for the Action Items related to floodplain management planning. Progress was achieved through various projects that were designed or implemented, as noted above. Additionally, the Village has continued to implement and enforce the requirements of the NFIP and WDO.

### **Recommendations**

The Engineering Division will continue to pursue the projects identified in the Village's Master Stormwater Management Plan and other improvements to the public storm sewer and sanitary sewer systems, to enforce the floodplain and stormwater management regulations in the WDO including those in our local amendment (Appendix P), to complete the activities required for our status in the Community Rating System, and will coordinate as needed with Lake County representatives for the 2022 5-Year Plan Update.
